

ANZ TERM DEPOSIT (FOR BUSINESS PURPOSES)

TARGET MARKET DETERMINATION

PURPOSE OF THIS DOCUMENT

ANZ is legally required to prepare this Target Market Determination (TMD). The TMD describes the class of customers the product has been designed for, the conditions under which the product must be distributed and how ANZ will review this document so it remains appropriate.

TARGET MARKET

ANZ has identified the target market for ANZ Term Deposit (for business purposes) and the key attributes of the product that meet the needs, objectives and financial situation of customers in the target market as follows:

ANZ Term Deposit (for business purposes) has been designed for customers who:	Key attributes of ANZ Term Deposit (for business purposes) that make the product appropriate for the target market:
<ul style="list-style-type: none">• Are running a business (whether or not for profit);	<ul style="list-style-type: none">• Eligibility: ANZ Term Deposit (for business purposes) is only available for business purposes
<ul style="list-style-type: none">• Have funds in excess of the minimum deposit amount on which they want to earn a fixed rate of interest (subject to market rates);	<ul style="list-style-type: none">• Minimum deposit: a minimum deposit amount is required.• Interest: Interest is payable on deposited funds at an agreed rate and agreed frequency (which is fixed during the term of the deposit).
<ul style="list-style-type: none">• Are willing to put their funds on deposit for a specified minimum term; and	<ul style="list-style-type: none">• Term: Funds are held for an agreed term.• Rollover: Customers can elect for deposited funds to be repaid or reinvested at maturity. In some cases, funds may be automatically reinvested at maturity.
<ul style="list-style-type: none">• Do not require access to their funds on demand, but may want to withdraw the funds prior to the end of the specified term for a fee.	<ul style="list-style-type: none">• Early withdrawal: Customers may withdraw funds before the end of the agreed term on notice and these requests are generally processed on the same day or next business day. Early withdrawal incurs an administration fee and results in a reduction in interest payable in respect of the withdrawn funds.

DISTRIBUTION CONDITIONS

ANZ applies the following conditions and restrictions to the distribution of ANZ Term Deposit (for business purposes) so that the product is likely to be provided to customers in the target market.

These conditions and restrictions:

- limit the channels through which the product can be provided;
- ensure those who distribute the product are adequately trained and accredited; and
- ensure ANZ only distributes the product in accordance with a consistent application and assessment process.

Channel	<p>ANZ Term Deposit (for business purposes) can only be provided to customers through the following channels:</p> <p>ANZ Commercial;</p> <p>ANZ National Business Centre;</p> <p>ANZ Branches; and</p> <p>ANZ Private.</p> <p>ANZ Term Deposit (for business purposes) cannot be distributed by third parties. Brokers may refer customers to ANZ, however only authorised ANZ staff may decide to issue the product to a customer.</p>	<p>By limiting channels, ANZ can ensure that ANZ Term Deposit (for business purposes) applications are only received through channels that are subject to appropriate conditions, controls and/or monitoring.</p>
Training & Accreditation	<p>ANZ Term Deposit (for business purposes) can only be provided to customers by ANZ directly, or through authorised ANZ staff who are accredited and trained.</p>	<p>By applying training and accreditation standards to ANZ staff who distribute the product, ANZ is ensuring:</p> <ul style="list-style-type: none"> • background checks are conducted on relevant individuals; • those distributing the product hold appropriate qualifications, are authorised to engage in distribution activities and are appropriately trained and accredited to ANZ standards; and • those distributing the product understand the distribution process ANZ requires them to follow, as well as the legislative framework relevant to their activities.
Process	<p>ANZ Term Deposit (for business purposes) can only be provided to customers by following ANZ's customer application and product selection process, including making relevant enquiries into the customer's product needs.</p>	<p>By applying its application and product selection process, ANZ makes enquiries to determine whether the product is consistent with the likely needs, objectives and financial situation of the customer.</p>

REVIEW OF THE TARGET MARKET DETERMINATION (TMD)

ANZ will review the TMD periodically to ensure it remains appropriate.

Periodic Reviews of the TMD	Timing
<ul style="list-style-type: none">Initial review	<ul style="list-style-type: none">No later than 18 months from the date the TMD is made.
<ul style="list-style-type: none">Subsequent ongoing review	<ul style="list-style-type: none">No later than 18 months from the date of the previous review.

Review Triggers

In addition, ANZ will review this document earlier if one or more of the following occurs, where they reasonably suggest that the TMD is no longer appropriate:

- There is a material change to the product or its distribution. For example, a change to a key product attribute or a material change to a distribution channel.
- There is a change in law or its application, a change in relevant industry code, an AFCA determination, a court decision, or ASIC or other regulatory guidance or action (including APRA requirements) that materially affects the product. For example, if a change in the law requires ANZ to change or remove a key product attribute or a product intervention order is made by ASIC in respect of the product.
- There is a significant increase beyond expected levels in complaints or disputes, or a significant change in the nature of complaints or disputes relating to the product.
- ANZ has information about the way in which the product is being distributed, operating or being used by customers that reasonably suggests the TMD is no longer appropriate. For example, ANZ will monitor the number of accounts that are closed prior to maturity, particularly if this occurs shortly after the product is issued.
- Any other event occurs or information is received (for example, significant dealings in the product that are not consistent with the TMD) that reasonably suggests the TMD is no longer appropriate.

REPORTING

Regulated persons must provide the following information to ANZ:

Every calendar quarter.	As soon as practicable and in any case within 10 business days of the relevant reporting period.
