



# ANZ OneAnswer - First Sentier Global Credit Income Trust – change to transaction suspension

CONTINUOUS DISCLOSURE NOTICE | 7 JUNE 2024

This document acts as a Continuous Disclosure Notice to current investors of the OneAnswer - First Sentier Global Credit Income Trust (ARSN 115 529 452) which is available through ANZ OneAnswer Investment Portfolio (including //Select).

## What are the changes?

The suspension on withdrawal transactions for the OneAnswer - First Sentier Global Credit Income Trust ("OneAnswer Fund") will be removed from 12pm (AEST/AEDT) on 7 June 2024.

- Switches out of the OneAnswer Fund can now be accepted, effective from 7 June 2024.
- For investors in the OneAnswer Fund through OneAnswer Investment Portfolio (including Frontier), withdrawal requests can now be accepted, effective from 7 June 2024.

The suspension on applications or additional investments to the OneAnswer Fund will continue to apply.

- No applications or additional investments/contributions or switches into the OneAnswer Fund will be accepted, effective from 9 May 2024. This suspension continues to apply.

## Why are we making these changes?

The First Sentier Global Credit Income Fund\* ("Underlying Fund"), into which the OneAnswer Fund invested, suspended applications and withdrawals on 24 April 2024 and was terminated on 21 May 2024. The cash proceeds have now been received from the Underlying Fund, so the suspension on withdrawals and switches out has been removed effective from 7 June 2024.

\*First Sentier Investors (Australia) IM Ltd (ABN 89 114 194 311) is the investment manager and The Trust Company (RE Services) Limited (ABN 45 003 278 831) is the Responsible Entity of the Underlying Fund.

## What do the changes mean for you?

Your current investments will continue within the OneAnswer Fund. However, if you want to make a full or partial withdrawal from the OneAnswer Fund or switch your investment to another investment fund available in the OneAnswer Investment Portfolio (including Frontier and //Select), you can do so after 7 June 2024.

## What happens next?

We expect to confirm the details of the new investment strategy for the OneAnswer Fund before the end of June 2024. Your current investments will continue to be managed prudently and in line with the approach outlined in the OneAnswer Investment Funds Guide, which is part of the Product Disclosure Statement.
